Consideration of proposed Resolution 21-02 to authorize the issuance of Enhanced Tobacco Settlement Asset-Backed Bonds, in order to defease and refund all or a portion of the Enhanced Tobacco Settlement Asset-Backed Bonds, the restructuring of an escrow fund, and certain related matters entitled:

A RESOLUTION OF THE GOLDEN STATE TOBACCO SECURITIZATION CORPORATION AUTHORIZING THE SALE, ISSUANCE AND DELIVERY OF ENHANCED TOBACCO SETTLEMENT ASSET-BACKED BONDS IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$2,000,000,000 TO DEFEASE AND REFUND ALL OR A PORTION OF CERTAIN OF THE OUTSTANDING GOLDEN STATE TOBACCO SECURITIZATION CORPORATION ENHANCED TOBACCO SETTLEMENT ASSET-BACKED BONDS; AUTHORIZING THE RESTRUCTURING OF AN ESCROW FUND; DETERMINING AND PRESCRIBING CERTAIN MATTERS; APPROVING AND AUTHORIZING THE EXECUTION AND DELIVERY OF VARIOUS DOCUMENTS RELATED THERETO; RATIFYING ANY ACTION HERETOFORE TAKEN; AUTHORIZING FUTURE ACTIONS AND APPROVING RELATED MATTERS IN CONNECTION WITH THE BONDS AND THE BONDS TO BE DEFEASED AND REFUNDED.
